The Portal uses cookies as described below.

By clicking the "ok" button on the EMVO Portal Cookie Banner, you are agreeing to our use of cookies and similar technologies in line with your current cookie setting and in accordance with this Cookie Policy

If you do not agree to our use of cookies in this way, you should set your browser settings accordingly. You will always be able to withdraw your consent and change your choice by amending your browser settings in the future. If you disable cookies that we use, this may impact your user experience while on this Portal.

1. What are cookies?

Cookies are files or pieces of information that may be stored on your computer (or other internet enabled devices, such as a smartphone or tablet) when you visit this Portal. A cookie will usually contain the name of the website from which the cookie has come from, the "lifetime" of the cookie (i.e. how long the cookie will remain on your device), and a value, which is usually a randomly generated unique number.

Two types of cookies may be used, "session cookies" and "persistent cookies". Session cookies are automatically deleted at the end of your browsing session. Persistent cookies remain longer on your device, for the duration of each specific cookie, and will remain valid until its set expiry date (unless deleted by the user before the expiry date).

Cookies can be used by web servers to identify and track users as they navigate different pages on a website and identify users returning to a website. Cookies do not contain any information that personally identifies you, but personal information that EMVO stores about you may be linked to the information stored in and obtained from cookies.

2. For what purposes does this Portal uses cookies?

Many cookies on this Portal perform essential functions or services your have requested or are used for security purposes, as further described in the section below.

EMVO uses cookies to make this Portal easier to use. Cookies may also be used to help speed up your future activities and experience on the Portal by maintaining your preferences over time. We may also use cookies to detect fraud and abuse of the Portal, to compile anonymous, aggregated statistics that allow us to understand how users use the Portal and to help us improve the structure and content of the Portal (for example, by monitoring which features of the Portal are being used,

which pages are visited, how often, and what information is downloaded) as well as to enable you to provide feedback on the Portal and to ensure that the Portal remains up and running.

3. What types of cookies does the Portal use?

The table below summarises the different types of cookies we use on the Portal, together with their respective purposes and duration.

(i) Third party Cookies

Cookie Name	Purpose of the Cookie	Duration of the Cookie
MUID,MC1and MSFPC	Identifies unique web browsers visiting Microsoft sites. These cookies are used for advertising, site analytics and other operational purposes.	Persistent
ANON	Contains the ANID, a unique identifier derived from your Microsoft account, which is used for advertising, personalisation and operational purposes. It is also used to preserve your choice to opt out of interest-based advertising from Microsoft if you have chosen to associate the opt-out with your Microsoft account.	Persistent
CC	Contains a country code as determined from your IP address.	Persistent
PPAuth,MSPAuth, MSNRPSAuth, KievRPSAuth	Helps to authenticate you when you sign in with your Microsoft account.	Persistent
NAP	Contains an encrypted version of your country, postcode, age, gender, language and occupation, if known, based on your Microsoft account profile.	Persistent
MH	Appears on co-branded sites where Microsoft is partnering with an advertiser. This cookie identifies the advertiser, so the right ad is selected.	Persistent
MR	Used to collect information for analytics purposes.	Persistent
TOptOut	Records your decision not to receive interest-based advertising delivered by Microsoft.	Persistent

When you visit the Portal, you may receive cookies from third party websites or domains. We do not control the placing of these cookies and you should check the relevant third party's website for

more information about these cookies. The relevant third party is responsible for providing you with information regarding the cookies they place and obtaining your consent before placing cookies on your device.

The Portal may also contain electronic images known as web beacons (also called single-pixel gifs) that Microsoft uses to help deliver cookies on the Portal, count users who have visited the Portal and deliver co-branded products.

4. How can you control, delete or withdraw your consent to the use of cookies ?

If you wish to withdraw your consent to our use of cookies on this Portal, or if you wish to delete or control the placing of cookies on your computer, you can change your browser settings to block cookies or to alert you when cookies are being sent to your device. Any change to this Cookie Policy will be posted on this page and notified to you by e-mail (where appropriate or required by law and to the extent that you have provided us with your e-mail address). We shall indicate at the top of the Cookie Policy the date when it was most recently updated.

6. What are your rights

You, as individual whose personal data is processed as described in this Cookie Policy, have a number of rights which are summarized in broad terms as laid down in the following list. Please note that exercising these rights is subject to certain requirements and conditions as set forth in applicable law.

If you wish to access personal data about you or exercise any of the rights listed below, you should apply in writing to the contact person identified in Section 7 below.

6.1. Right to withdraw consent

If you have declared your consent for any Personal Data processing activities as described in this Cookie Policy, you can withdraw this consent at any time with future effect. Such a withdrawal will not affect the lawfulness of the processing prior to withdrawal of the consent.

6.2. Right of access

You have the right to obtain confirmation from us as to whether or not your personal data is processed, and, where that is the case, to request access to that personal data including, without limitation, the categories of personal data concerned, the purposes of the processing and the recipients or categories of recipients. We do have to take into account the rights and freedoms of others, so this is not an absolute right. If you want to request more than one copy of the personal data, we may charge a reasonable fee based on administrative costs.

6.3. Right to rectification

You have the right to obtain from us the rectification or completion of inaccurate or incomplete personal data concerning you.

6.4. Right to erasure ('right to be forgotten')

You have the right to obtain from us the erasure of personal data concerning you in certain circumstances as defined under applicable law.

6.5. Right to restriction of processing

In certain circumstances as defined under applicable law, you have the right to request that we restrict processing of personal data about you.

6.6. Right to data portability

In certain circumstances as defined under applicable law, you have the right to receive personal data concerning you, which you have provided to us, in a structured, commonly used and machine-readable format and you may have the right to transmit that personal data to another controller.

6.7. Right to object

In certain circumstances as defined under applicable law, you have the right to object, on grounds relating to your particular situation, at any time to the processing of personal data about you by us and we can be required to no longer process personal data about you.

Personal data about you will not be used for direct marketing purposes.

7. How to contact us

You must provide evidence of your identity in order to exercise any of the rights listed in Section 6 above.

Any communication from us in relation to your rights as detailed in Section 6 above will be provided free of charge. However, in case of requests that are manifestly unfounded or excessive, in particular because of their repetitive character, EMVO may charge a reasonable fee taking into account the administrative costs of providing the information or communication or taking the action requested; or refuse to act on the request.

We invite you to report any complaints about processing of your personal data to EMVO in its capacity as data controller. EMVO will investigate and attempt to resolve the complaint. You also have the right to lodge such complaint with the competent authority, in particular in the Member State of your habitual residence, place of work or of an alleged infringement of the General Data Protection Regulation (EU) 2016/679 of 27 April 2016.
